	If one (1) offer for an overhoused transfer is declined (or there is a failure to respond to an offer within the specified period) during the CHR Overhoused Period, the household will cease to be eligible for Rent-Geared-to-Income and shall pay rent for the unit it occupies at the rent payable for the unit by a household not receiving Rent-Geared-to-Income support, pursuant to the provisions for rent changes under the Housing Services Act. At time of offer, a unit inspection may be conducted. The household will be required to pay for repairs. Tenants must move within 7 days of an accepted transfer offer.
